Dear Supporters, Partners, and Nexus Members,

I am so pleased to share with you the Nexus Family Healing 2024 annual report, a year in which **nearly 4,700 youth and families found the critical mental health care** needed to start a path toward a brighter future.

Because of you, more individuals in our communities are getting the mental health care they need, and those already in our care are experiencing strong, impactful programs.

Every day, families face the difficult journey of finding appropriate support. We hear stories about the difficult journeys families face and how the lack of access to care is leading to unimaginable, often tragic, situations.

At Nexus, year after year, we work to increase access through launching **new programs, expanding our services**, and advocating that **critical programs currently in place** remain funded and strong. We are so grateful to all of you who fearlessly work alongside us in this commitment.

Together, this past year, we grew in the following ways:

- More Minnesota families facing mental, behavioral and emotional crisis are getting in-person immediate help through extended hours and a wider range of clients served by our Family Response and Stabilization Services program.
- North Dakota youth in foster care with a diagnosis of mental or behavioral health issues now have a whole team of experts in their corner providing extra, intensive support with our new wrap-around Treatment Foster Care services.
- Youth in Oregon, who have mental and behavioral health challenges and are involved in the juvenile justice system, now have restorative support as our expert staff provides assessments, and a healing environment while justice issues are being sorted through.

You have also helped **existing programs stay vibrant and strong**:

- You have provided access to recreational activities and special outings that not only support our youth's physical and mental needs but let "kids just be kids."
- You have boosted aftercare programs, where youth leaving our residential programs or foster care, aren't just cut off from support but have help transitioning out of care and moving forward on their own.
- Your support ensures individuals experiencing a mental health crisis who are living in the under-served mental health area of southeast Minnesota can continue to count on immediate access to care through the Southeast Regional Crisis Center.

There are so many more examples where you are making a real, **life-saving difference** to others. Our commitment to increase access to mental health care is unwavering. We know, together, we can help children and families get the help they so desperately want and find a future filled with remarkable possibilities.

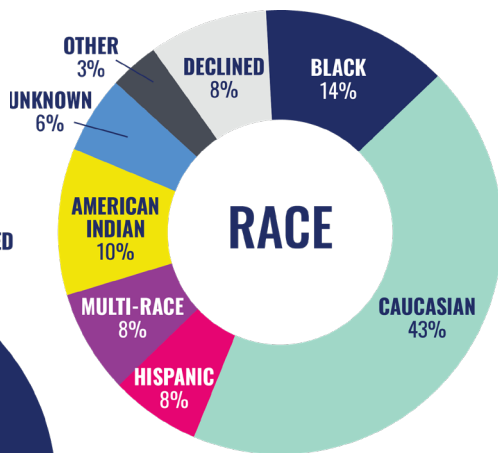
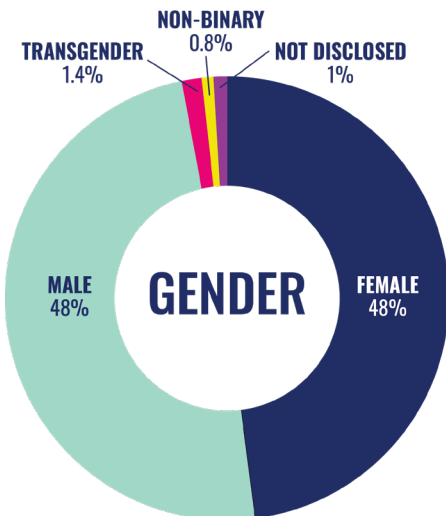
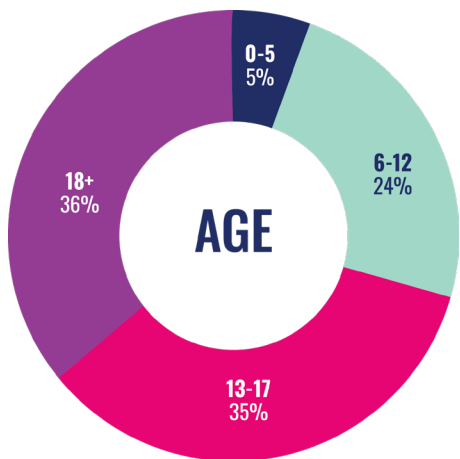

RESIDENTIAL SERVICES

When each youth enters our care, we use the Child and Adolescent Needs and Strengths Assessment to determine their level of need and address their behavioral health treatment plans. One of the areas this assessment evaluates is exposure to traumatic events.

Over 60% of the youth we serve have experienced four or more traumatic events in their young lives, compared to 50% of the general population experiencing at least one traumatic event in their lifetime.

- 73% Disruptions in Caregiving/Attachment Loss
- 56% Emotional Abuse
- 52% Neglect
- 51% Witness to Family Violence
- 46% Physical Abuse
- 39% Parental Criminal Behavior
- 39% Bullied by Others
- 35% Sexual Abuse
- 24% Witness to Community/School Violence



Support Today Stops Struggles Tomorrow

The youth we serve simply can't wait for mental health care. When mental health is untreated it can lead to increased suicide rates, chronic health conditions, poor school performance, involvement in the juvenile justice system, homelessness, substance abuse, and more. Access to services is critical, and together, with your support, we can help more youth in need.

We are so proud of the quality mental health care our expert team members provide thousands of youth, adults, and families every year – helping them find a better place.

98% of youth reported being engaged in school or work.



95% reported that they had a safe and stable place to live.



81% reported feeling connected to their community.



92% believed that their lives were better because of what they learned in the program.

Taylor's Story

At 17, Taylor* was experiencing repeated outbursts of intense anger. Her behavior wasn't just emotionally charged—it was taking a toll on her entire family. As the situation grew more volatile, her parents became increasingly fearful, unsure of how to keep their daughter or their home safe. One night, at 11 p.m. in the dead of winter, they made a desperate call to Nexus Family Healing's Family Response and Stabilization Services (FRSS).

"There was so much discord and friction," said Kayla Renney, Program Manager for FRSS, "Her caregivers had felt that because there were so many things needed to be done to repair the relationship, they didn't think they'd be able to get help."

One of the most impactful elements of FRSS is its rapid response. The team arrived in-person within an hour—something they're able to do 24/7, 365 days a year. That immediate support was a turning point.

"Taylor and her family's story truly illustrate the critical role—and the life-changing impact—of the youth crisis services we provide here at Nexus Family Healing," said Renney. "It highlights the importance of our crisis response model, which is the only one of its kind in the entire state of Minnesota."

In the following days and weeks, Taylor's family received three additional in-home visits and eight weeks of stabilization services. The FRSS team focused not only on crisis de-escalation but also long-term healing. Taylor began individual therapy to address underlying trauma, while the family worked with an in-home therapist to rebuild communication and trust.

This early intervention helped Taylor avoid hospitalization, juvenile detention, or being removed from her home—all too common outcomes when youth in crisis don't get support. The structure of the program gave her the tools to develop healthier coping skills and start to feel more secure.

By the time services wrapped up, the shift was clear. Taylor's behavior had stabilized. Her family felt more connected and supported. They were hopeful again—and had access to long-term resources to help maintain their progress.

"This is just one of many stories that remind us that youth crisis services are not just about responding to suicide risk," said Renney, "which is also an important part of our work, but the uniqueness of our crisis model is that we allow our families to define their crisis, and they do not need to reach anyone's defined level of need but their own."

Thanks to the timely support of FRSS, Taylor and her family didn't just survive a crisis—they found a path to healing.

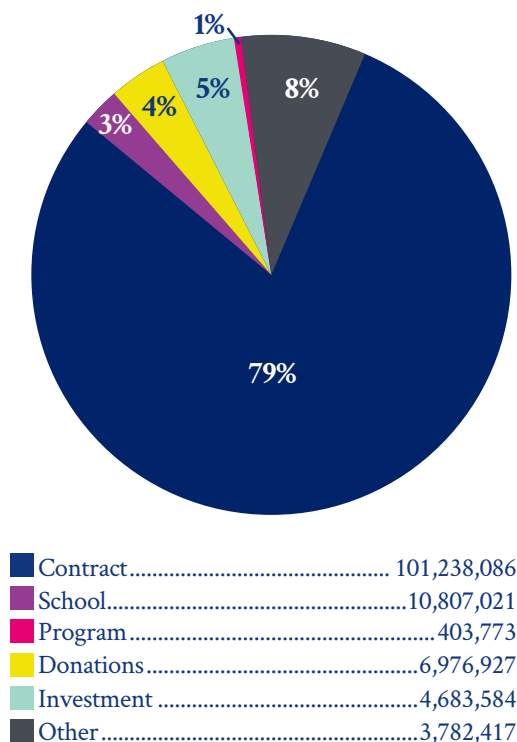

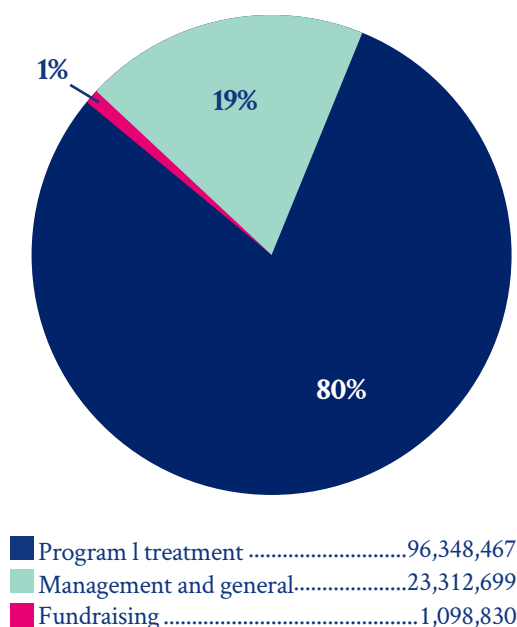
Revenue

Expenses

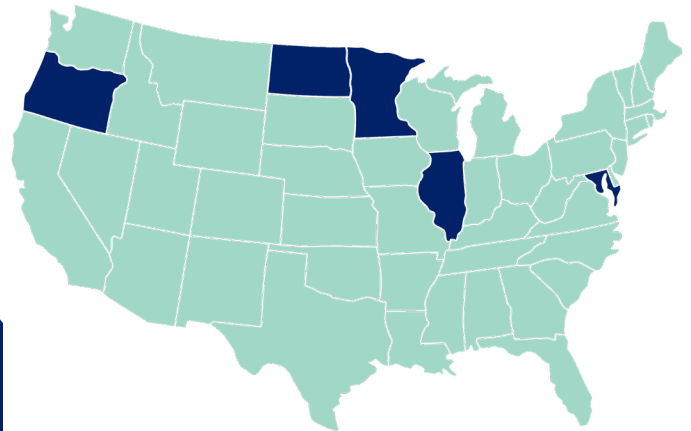
