Nexus-Kindred Family Healing, an affiliate of Nexus Family Healing
(another MN-based nonprofit organization) is one of the largest private
foster care providers in MN. In 2021, Nexus-Kindred Family Healing
provided emergency foster care, foster care, shelter, and short-term
foster care to 362 unique youth, with a total of 434 foster care
enrollments. Nexus-Kindred served 59 unique youth through adoption
services and 67 youth through visitation services. A total of 570
enrollments occurred in 2021 that supported safety, healing, and
permanency for children and youth. Over 60% of MN counties were served
and four states outside of Minnesota.
